The bonuses include two new songs and eight new versions of his classic tunes, some recorded live. Putting all of the assessments aside for a moment, what impresses most is the stunning beauty of Ellis Paul's art. Just listening to the music and taking it all in - you become swept away by the songs and immersed in the stories they tell.
